ORDINANCE NO. 20577

ORDINANCE

introduced by City Manager Dr. Robert M. Perez amending the "District Map" referred to and made a part of the Zoning Ordinances by Section 18.50.050 of the Topeka Municipal Code, by providing for certain changes in zoning on 3.62 acres of property located at the northwest intersection of SE 21St St. and SE Adams St. from "M-1" Two-Family Dwelling District and "M-2" Multiple-Family Dwelling District to "C-2" Commercial District. (Z25/04) (Council District No.3)

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF TOPEKA, KANSAS:

<u>Section 1</u>. That the "District Map" referred to and made part of the Zoning Ordinances by Section 18.50.050 of the Topeka Municipal Code (TMC), be, and the same is hereby amended, by reclassifying the following described property:

FOR 43.32 FEET TO A POINT ON THE EAST LINE OF LOT 212 ON 21ST STREET IN SAID HEERY'S 2ND SUBDIVISION, SAID POINT BEING 30.00 FEET NORTH OF THE SOUTHEAST CORNER OF SAID LOT 212 ON 21ST STREET; THENCE S. 88° 00' 23" W. FOR 90.95 FEET TO THE EAST LINE OF LOT 206 ON 21ST STREET IN HEERY'S

2ND SUBDIVISION, SAID POINT BEING 30.00 FEET NORTH OF THE SOUTHEAST CORNER OF SAID LOT 206 ON 21ST STREET; THENCE S. 77° 45' 58" W. FOR 56.21 FEET; THENCE S. 88° 00' 23" W. FOR 70.00 FEET TO THE WEST LINE OF LOT 198 ON 21ST STREET IN SAID HEERY'S 2ND SUBDIVISION, SAID POINT BEING 20.00 FEET NORTH OF THE SOUTHWEST CORNER OF SAID LOT 198 ON 21ST STREET: THENCE S. 88° 00' 23" W. FOR 50.00 FEET TO THE EAST LINE OF LOT 196 ON 21ST STREET IN SAID HEERY'S 2ND SUBDIVISION, SAID POINT BEING 20.00 FEET NORTH OF THE SOUTHEAST CORNER OF SAID LOT 196 ON 21ST STREET; THENCE S. 88° 00' 23" W. FOR 16.00 FEET TO THE NORTHWEST CORNER OF LOT 701 ON ADAMS STREET IN SAID HEERY'S 2ND SUBDIVISION; THENCE N. 88° 00' 49" E. ON THE NORTH LINE OF SAID LOT 701 ON ADAMS STREET FOR 113.71 FEET TO THE POINT OF BEGINNING. SAID TRACT CONTAINS 3.62 **ACRES**

FROM "M-1" Two-Family Dwelling District and "M-2" Multiple-Family Dwelling District to "C-2" Commercial District

Section 2. This Ordinance Number shall be fixed upon the "District Map."

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

<u>Section 4.</u> This Ordinance shall take effect and be in force from and after its passage. Approval and publication in the official city newspaper.
