CHARTER ORDINANCE NO. 125

A CHARTER ORDINANCE introduced by City Manager Dr. Robert M. Perez, amending the City's Charter Ordinance levying the transient guest tax, revising the structure to allow the City to recoup its investment costs of Hotel Topeka.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF TOPEKA, KANSAS, THAT:

Section 1. That Section 2 of Charter Ordinance No. 120, as codified in § A15-17, of The Code of the City of Topeka, Kansas, is hereby amended to read as follows:

Levied – Amount.

- (a) Effective November 14, 2015 and continuing through December 31, 2027, a transient guest tax of seven percent shall be levied in the City of Topeka, Kansas, upon the gross rental receipts derived from or paid directly or through an accommodations broker by transient guests for lodging or sleeping accommodations, exclusive of charges for incidental services or facilities, in any hotel, motel, or tourist court. Funds shall be distributed pursuant to resolution and agreement.
- (b) Effective January 1, 2028, and continuing through December 31, 2032, a transient guest tax of six percent shall be levied in the City of Topeka, Kansas, upon the gross rental receipts derived from or paid directly or through an accommodations broker by transient guests for lodging or sleeping accommodations, exclusive of charges for incidental services or facilities, in any hotel, motel, or tourist court.
- (c) Effective January 1, 2033, a transient guest tax of five percent shall be levied in the City of Topeka, Kansas, upon the gross rental receipts derived from or paid directly or through an accommodations broker by transient guests for lodging or sleeping

accommodations, exclusive of charges for incidental services or facilities, in any hotel, motel, or tourist court.

- (d) Notwithstanding anything to the contrary, the total transient guest tax collected at Hotel Topeka in the year 2025 shall constitute the "base year". Effective January 1, 2026, the transient guest tax rate levied at Hotel Topeka shall be eight percent, Any transient guest tax collected at Hotel Topeka in excess of the base year that is not contractually obligated shall be used solely by the City to recoup its investment costs of Hotel Topeka which include the purchase price, capital expenses, and operating losses incurred by the City through the date of sale. This provision shall expire upon complete reimbursement.
- <u>Section 2</u>. This Ordinance shall be published once each week for two (2) consecutive weeks in the official City newspaper.
- Section 3. This Charter Ordinance shall take effect sixty-one (61) days after final publication unless a sufficient petition for a referendum is filed and a referendum held on this Charter Ordinance as provided in Article 12, Section 5, Subdivision (c)(3), of the Kansas Constitution, in which case this Charter Ordinance shall become effective if approved by a majority of the electors voting therein.
- Section 4. Upon the effective date of this Charter Ordinance, this Charter Ordinance shall be recorded by the City Clerk in a book maintained for such purposes with a statement of the manner of adoption and a certified copy shall be filed with the Secretary of State of the State of Kansas.
- Section 5. That Section 2 of Charter Ordinance No. 120, as codified in Topeka Municipal Code § A15-17 is hereby specifically repealed.
